The Tremper Baseball program, along with the Andy Smith Field Committee, would like to make you part of our tradition.

Prior to the 2013 Season, we were able to make some major upgrades and renovations to the baseball field behind the school. Tremper along with travel teams from all over the Midwest played over 120 games on it! The vision of the Baseball program, the Sponsorship Committee, the school and the coaching staff is to make this a "state of the art" baseball facility and organization..... Therefore, our job is not complete!

In spring 2014, we'll have our formal ceremony to celebrate the naming of ANDY SMITH FIELD. In 1954, Smith, a Wausau native and UW graduate, fielded Kenosha High School's first baseball team and success was instantaneous. Led by left-handed phenoms Bob Hartman and Bob Lee, the inaugural KHS team finished second at State. Eight years later, led by another great pitcher in Dick Bosman, Smith guided KHS to another runner-up finish. A year later, KHS and Smith finally reached the top and captured the State championship, a feat he would repeat in 1969 after moving to Tremper. During a 10-year span, Smith, who died in 2003, won 82 percent of his games. In his 21 years as a baseball coach in Kenosha, Smith put together 18 winning seasons. He was selected to the Wisconsin Baseball Coaches Association Hall of Fame in 1980 and the Kenosha Athletic Hall of Fame in 1984. Smith guided Kenosha High School and Tremper to six State Tournament appearances between 1953 and 1973. Kenosha High won its first title under Smith in 1963 and Tremper won its lone state championship under Smith in 1969. Smith also coached three state runner-up squads. During a 10-year span in his coaching career, Smith compiled a 134-30 record, a .817 winning percentage, and in 21 years, he had 18 winning seasons.

SPONSORSHIP PROGRAM Advertising Contract

1. This Advertising Contract ("Agreement") is entered into this _____ day of _____, _____ by and between Kenosha Unified School District #1 ("KUSD #1") and _____ ("Advertiser")
2. Tremper High School has made great progress this past year and will continue to make necessary improvements to its baseball field. The Kenosha Unified School District #1 Board of Education ("Board") has authorized the Tremper Trojans Baseball team to place advertising signage on the interior portion of its outfield fence.
3. Advertising signs are to be made of solid plastic core with aluminum faced material and will be 4' x 8' in size. The Advertiser must provide their logo/design artwork for approval by Tremper baseball and KUSD #1. Once approved, the advertiser must provide the artwork in the proper format. The preferred formats are ai, eps, or pdf. Signs will be placed horizontally on the outfield fence. Signs will be installed, managed and maintained by the Trojan baseball coaching staff and parents. Sign replacement costs are the responsibility of the Advertiser.
4. The length of the Agreement is based on the number of years purchased. Day 1 of the agreement will start 04/01/14. This will be done to allow time for construction and placement on the outfield fence. Signs sold after 08/01/13 will be hung on or around 04/01/14.
5. Advertiser agrees to pay (via check) for the sign within 5 days after contract is signed. Tremper Baseball will mail an invoice to the advertiser. Checks should be made out to Tremper Baseball. A Representative from the baseball team will make arrangements to have the sign made and will disperse a receipt letter to sponsor for sign advertising contributions. All sign purchases are tax deductible. The contract period terms are below:

Contract Period (Years)	Advertiser Costs (Dollars)
1 Year	\$500
2 Years	\$600
3 Years	\$850
5 Years	\$1,000
6. Advertiser will have the option to purchase ongoing advertising in two year increments for \$500 after the end of their initial contract period.
7. Advertiser understands and agrees that Kenosha Unified School District #1 is not in any way restricted by this Agreement from granting advertising rights to others, including competitors of Advertiser, as may be determined by KUSD #1 in its sole discretion.
8. In the event that KUSD #1 and Advertiser are unable to agree upon the design, color, or wording of the sign, KUSD #1 may, in its sole discretion, at any time, unilaterally terminate this Agreement and have no further obligation hereunder.
9. Checks should be made out to Tremper Baseball. A Representative from the baseball team will make arrangements to have the sign made and will disperse a receipt letter to sponsor for sign advertising contributions. All sign purchases are tax deductible.
10. Nothing in this Agreement between Kenosha Unified School District #1 and Advertiser shall create any rights whatsoever on behalf of Advertiser against KUSD #1, and/or its officers, directors, agents or assets.
